This waiver basically states that you are 18 years old or older, agree with all of our warranty terms and policies, and that you (the customer) are responsible for your actions and waive any liability from Plycon's Armory Inc. in relation to your purchase and use of airsoft replicas.

I _____ (buyer prints name) the buyer of any products from Plycon's Armory, Inc. hereby state that I have read and understood all warnings, liabilities, terms of sale, and warranties (no refunds ever offered and a limited seven day internal defect only returns policy) related to the products offered by Plycon's Armory, Inc. and will not hold Plycon's Armory, Inc. it's employees, owners, associates, liable or responsible for any legal action or situation related to my purchase of products from them.

I _____ (buyer prints name) state that I am 18 years old or older and that to the best of my knowledge – airsoft is legal to own where I live. If my order is seized due to airsoft being illegal in my area – I understand that I will not receive any type of refund from Plycon's Armory, Inc. It is my responsibility to know if Airsoft is legal or not in my area – not Plycon's Armory, Inc. I also state that I have never been convicted of a felony. I also understand that federal laws state that the use of any look-alike toy gun in the use of a crime carries the full ramifications of using a real gun. I also understand that removing the orange blaze markings on the end of the barrel and any warning stickers is a violation of federal law and may make the replica appear to be real - which might result in my own death if I brandish the replica towards anyone who might feel that I am threatening them with a real weapon.

I _____ (buyer prints name) fully understand and acknowledge that risks and dangers exist in my use of airsoft equipment and my participation in airsoft activities which may result in injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability. I, on behalf of myself, my personal representatives, and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Plycon's Armory, Inc. and it's owners, agents, officers, and employees from all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services, or otherwise which may arise out of my use of airsoft replicas purchased from them, or my participation in airsoft activities.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE PLYCON'S ARMORY, INC. FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE. I ALSO AGREE IN FULL TO THE LIMITED SEVEN DAY WARRANTY AND THE NO REFUND/NO RETURN POLICY FOR ANY PURCHASE MADE.
